The Vermont Pediatric Feeding Consortium is a group of pediatric OTs, SLPs and RDs that has been working hard to develop resources for professionals who work with the Pediatric Feeding Disorders. One of the Consortium's outcomes was the development of a School Based Feeding Record and Plan. This is an interdisciplinary document intended to help coordinate and plan a safe and effective feeding program for students with complex feeding needs in the school environment.

A subcommittee of the consortium has also developed a presentation describing what a pediatric feeding disorder is and why the diagnosis is important for children with the disorder. This presentation was given at Pediatric Grand Rounds as well as for a group of Maternal and Child Health Nurses. A Pediatric Feeding Disorder Screener developed by Feeding Matters, will hopefully be used as part of the intake for early intervention. The implementation of the screener may yield more referrals to OTs and SLPs for feeding therapy. We have also been discussing the lack of qualified feeding therapists in the State of Vermont. Our next step is to look into trainings for therapists who want to do more feeding therapy in their practices. 

#### Notes from Vermont's NBCOT Ambassador:

- Starting in 2027, NBCOT is instituting a new rule in which members must renew certification within 3 cycles. Those who let their 'R' or 'C' lapse after 3 cycles will be required to take the certification exam again.
- (3 cycles = 9 10 years)
- If you earn more than the required 36 CAUs toward registration, you can apply CAUs earned in the last year toward the next renewal cycle.
- CE Broker is a service available through NBCOT which keeps track of continuing education requirements earned.
- Did you know that the NBCOT Navigator offers free continuing education on topics ranging for Driving and Community Mobility, Coronavirus, Falls Prevention, Fine Motor Delay, Dementia, Ergonomics, Spinal Cord Injury, and Telehealth?
- Proquest is a cool database allowing users to access current evidence based practice articles.
