Feeding Therapy Consortium

The Vermont Pediatric Feeding Consortium, which is a group of pediatric OTs, SLPs and RDs, has been working hard to develop resources for professionals who work with the Pediatric Feeding Disorders. One of the Consortium's outcomes was the development of a School Based Feeding Record and Plan. This is an interdisciplinary document intended to help coordinate and plan a safe and effective feeding program for students with complex feeding needs in the school environment.

A subcommittee of the consortium has also developed a presentation describing what a pediatric feeding disorder is and why the diagnosis is important for children with the disorder. This presentation was given at Pediatric Grand Rounds as well as for a group of Maternal and Child Health Nurses. A Pediatric Feeding Disorder Screener developed by Feeding Matters will hopefully be used as part of the intake for early intervention. The implementation of the screener may yield more referrals to OTs and SLPs for feeding therapy. We have also been discussing the lack of qualified feeding therapists in the State of Vermont. Our next step is to look into trainings for therapists who want to do more feeding therapy in their practices.
